



ALPG STANDARD TERMS OF PARTICIPATION

The completed entry form (**Form**) and these terms (including any incorporated terms) form a legally binding contract (**Agreement**) between the person named on the Form (**you**) and the Australian Ladies Professional Golf Inc Y0785945 (**ALPG**). By participating in any ALPG camp, clinic or event (**Event**), you agree to the terms of this Agreement.

1. ALPG will not process any Form which is incorrect, incomplete or not submitted by any specified due date. ALPG reserves the right to not accept any Form in its absolute discretion.
2. You warrant that the information provided on the Form is accurate and current, including in relation to medical conditions, dietary requirements and travel arrangements.
3. You agree:
 - a) all costs associated with attending an Event will be at your own expense, including any travel or accommodation costs;
 - b) to safeguard your personal property (such as bags and money) and acknowledge that ALPG is not responsible for any lost, stolen or damaged personal property;
 - c) you will not do anything to compromise your safety or the safety of others. You are responsible for your own conduct whilst at an Event and you must pay for the cost of repair of any damage caused as a result of your conduct;
 - d) to keep confidential all information or material concerning ALPG, including participation, high performance and coaching plans and any other information specified by ALPG as confidential. This obligation survives the expiry or termination of this Agreement for any reason;
 - e) you irrevocably and unconditionally consent without compensation to the recording, transmission and use of your image, likeness and/or voice by any means (including audio and visual recordings by television cameras and photographers) throughout the world, to the fullest extent possible in perpetuity, by ALPG;
 - f) to comply with ALPG's rules and regulations, any terms of admission of the venue for the Event and all laws, awards and regulations.
4. ALPG may terminate your participation at any time by notice in person or sent to the address provided on the Form, including if you do not comply with this Agreement, engage in serious misconduct or be a source of danger, nuisance or annoyance to others.
5. There are risks and inherent dangers associated with participating in golfing events and associated activities that may result in participants being injured. ALPG bears no liability for any personal injuries, health problems or death sustained at or after an Event, including directly or indirectly resulting from any existing medical condition.
6. You agree to not bring any claim or proceeding against ALPG for any damage, loss, injury or liability you may suffer in relation to the Event or your participation. Except for liability that by law cannot be excluded, ALPG excludes all liability to you in tort (including negligence), contract or bailment for acts or omissions of ALPG, its employees and contractors arising out of or in relation to the Event.

7. If ALPG is liable to you for any breach of this Agreement or any tort committed by ALPG (including negligence but not including fraud), ALPG's liability to you is limited (at ALPG's election) to ALPG repaying any amounts paid by you or supplying or resupplying any services to which you are entitled.
8. ALPG may postpone, cancel, interrupt or stop an Event due to adverse weather, dangerous situations or any other causes without any compensation to you. Any refunds will be at ALPG's discretion and ALPG is entitled to retain an administration fee.
9. ALPG respects the privacy of the individuals on whom it collects, uses and discloses personal information. Under the terms of the ALPG Privacy Policy, you may request access to personal information ALPG holds about you.
10. ALPG may choose not to enforce a term of this Agreement in some cases in its absolute discretion without affecting its right to enforce that term in other cases. All dates, times, and venues of Events may change without notice and without any compensation to you.
11. ALPG reserves the right to update, modify or change these terms from time to time. Any changes will be available on ALPG's website.
