

RACV ALPG PLAYERS CHAMPIONSHIP TICKETING TERMS AND CONDITIONS OF ENTRY

Australian Ladies Professional Golf Inc (**ALPG**) is the governing body for women's professional golf in Australia and New Zealand. ALPG owns the RACV Gold Coast Challenge (**Event**) staged at the RACV Royal Pines Resort, Gold Coast (**Venue**) and all commercial rights associated with the Event.

These terms apply to the Event and staged at any venue, stadium, arena or designated area that is controlled by ALPG (**Venue**) and (**Terms**).

By purchasing or holding a ticket, wristband or accreditation (**Ticket**), you agree to these terms including any incorporated terms (**Terms**). It is a condition of your ticket purchase for the Event and a condition of entry to the Venue that you comply with these Terms.

Refusal of Entry

1. For the comfort, safety and enjoyment of all patrons, ALPG and Venue management reserve the right to refuse entry to the Event:
 - a. if Ticket is damaged, defaced, forged or copied or has not been purchased from authorised sources;
 - b. persons deemed to be intoxicated, under the influence of drugs or disorderly or the presence of the person would be detrimental to, or compromise safety at, the Event;
 - c. persons wearing or displaying commercial, political or other offensive signage or logos (except for official merchandise or other Event related clothing worn in good faith);
 - d. unauthorised persons or persons not in possession of a valid Ticket or accreditation;
 - e. persons who refuse to be inspected or submit belongings for inspection;
 - f. of items which have the potential to cause injury or public nuisance, including Restricted and Prohibited Items; and
 - g. due to adverse weather, dangerous situations or any other causes that may affect the safety of patrons.

General Conditions of Entry

2. The following applies as a condition of entry into a Venue:
 - a. Venue reserves the right to inspect and search bags brought into or out of Venue;
 - b. Persons 12 years and under must be under the direct supervision of a ticket holding parent or legal guardian at all times;
 - c. You must not enter any Venue's restricted areas, such as back of house, competition and player areas, dressing rooms, VIP and hospitality areas or any other area not accessible by the public;
 - d. Pass-outs may be issued at the discretion of the Venue;
 - e. Narcotics (other than those prescribed by a registered medical practitioner) must not be taken into or out of the Venue;
 - f. Alcoholic beverages must not be taken into or out of the Venue. It is an offence for minors to purchase or consume alcohol or for persons to supply alcohol to minors. Alcohol may only be consumed in clearly marked areas of the Venue;
 - g. Smoking (including the use of electronic cigarettes or similar devices) is prohibited in certain areas of the Venue;
 - h. Unauthorised soliciting, collections and customer surveying is not permitted
3. You must not engage in any form of ambush marketing and must not conduct any activity that conflicts with, impairs, infringes or denigrates the rights of ALPG or any official sponsor of ALPG.

Eviction from Venue

4. ALPG or the Venue reserves the right to eject from the Venue without refund any patron who:
 - a. breaches any General Condition of Entry;
 - b. does not produce a valid Ticket on request;
 - c. is in breach of any of these Terms;
 - d. may unreasonably obstruct the viewing of other patrons;
 - e. may be a source of danger, nuisance, or annoyance or otherwise give rise to concerns in relation to the safety and security arrangements for an Event, including excessive noise, use of foul, obscene, abusive or racist language or gestures, the wearing or other display of commercial, political or offensive signage or logos, or the throwing of any object that might injure or cause damage to people or property;
 - f. fails to comply with instructions from a police or security officer;
 - g. is in possession of any item listed on the Restricted and Prohibited Items list;
 - h. is suspected of committing, or being likely to commit, or having committed a criminal offence within the Venue;
 - i. enters any area at the Venue which he/she may be prohibited to enter;
 - j. damages, interferes with or tampers with any ALPG or Venue property; or
 - k. refuses to comply with requests made by Venue or ALPG staff.

Restricted and Prohibited Items

5. The following restricted and prohibited items are not permitted into the Venue:
 - Glass
 - Illegal substances, including controlled, dangerous or illicit drugs
 - Flares or fireworks
 - Laser pointers
 - Weapons, or resemblance of weapons, including knives, firearms, blunt offensive objects, batons and those with sharp ends
 - Projectile items, including balls, frisbees, rackets or similar objects
 - Political or offensive materials
 - Recording devices (for commercial purposes) and tripods
 - Flag poles of more than 1 metre in length / banners or flags larger than 1m x 2m
 - Animals (other than trained assistance dogs)
 - Musical instruments and noise makers, including drums, whistles, air horns and loud hailers without the prior consent of Venue management
 - Other items as determined by ALPG that may cause injury, public nuisance or safety concerns.

No Resale at Premium

6. It is an essential condition of the right of admission to the Event conferred on the holder of a Ticket that you and each subsequent holder of the Ticket agrees with ALPG not to (without ALPG's prior written consent):
 - a. resell or transfer, or attempt to resell or transfer, the Ticket at a price greater than the face value of the Ticket (including via on-line auction sites);
 - b. use it for advertising, promotion, competitions or commercial purposes; and
 - c. bundle it with other goods or services, such as food and beverage, accommodation or transport.
7. If this condition is breached, ALPG may deny the holder admission to the Event and retain the price of the Ticket.

Patron Safety and Behaviour

8. You must comply with the directions or announcements from ALPG or Venue staff and any other requirements relating to access and safety given by ALPG or Venue staff or authorities.
9. You must maintain safe, prudent and respectful behaviour at all times. A patron is responsible for his or her own conduct whilst in the Venue for the Event and must pay for the cost of repair of any damage caused to the Venue as a result of their conduct.
10. You must not enter the competition performance areas of the Venue at any time and, if you do, you may be fined, expelled from the Venue and subject to legal action.

Liability and Risk

11. Patrons wishing to bring personal items into the Venue do so at their own risk. ALPG will not be held responsible for any damage to, loss or theft of, your personal property.
12. ALPG does not guarantee that you will have an uninterrupted and/or uninhibited view of the Event from your location within the Venue, nor does ALPG give any warranty as to the quality, content or duration of the Event.
13. There are risks and inherent dangers associated with attending Events and associated activities that may result in patrons being injured. You agree not to bring any claim or proceeding against ALPG for any damage, loss, injury or liability you may suffer in accessing the Venue or attendance at the Event.
14. Patrons attending the Event do so at their own risk, and assume all risk and liability for personal injury or death, including that of any minors under their care. ALPG bears no liability for any personal injuries, health problems or death sustained at or after the Event, including directly or indirectly resulting from any existing medical condition.
15. If ALPG is liable to you for any breach of these Terms or any tort committed by ALPG (including negligence but not including fraud), ALPG's liability to you is limited (at ALPG's election) to ALPG repaying any amounts paid by you or supplying or resupplying any Tickets to which you are entitled.

Photographs and Broadcasts

16. Cameras (including digital cameras), audio and video recorders may be brought into the Venue only at the discretion of ALPG.
17. Photographs taken within the Venue may be used only for private non-commercial purposes. For the avoidance of doubt, commercial purposes include licensing, merchandising, memorabilia, or marketing.
18. Patrons are not permitted to transmit, broadcast, sell, license or otherwise publish, disseminate or reproduce any recordings (including photographic, video or sound recordings) of the Event without ALPG's prior written approval.
19. If you make, reproduce or use any recording, data or image prohibited under this condition, you must assign in writing all copyright and intellectual property rights to ALPG or its nominee.
20. You may be photographed individually or in a crowd scene and/or your voice recorded at the Event, with or without your knowledge. You irrevocably and unconditionally consent without compensation to the recording, transmission and use of your likeness and/or voice by any means (including, audio and visual recordings by television cameras and photographers) throughout the world, to the fullest extent possible in perpetuity, by ALPG and its nominees.

Event Changes and Cancellation

21. ALPG may add, withdraw, reschedule or substitute players, artists, or teams (as applicable) or vary advertised programmes, prices, times, venues, seating arrangement or audience capacity without any compensation to you.
22. ALPG may postpone, cancel, interrupt or stop the Event, or deny access to the Venue, due to adverse weather, dangerous situations or any other causes without any compensation to you.
23. ALPG is not liable to you for any loss or damage you suffer as a result of the Event being cancelled, postponed or changed. ALPG disclaims the existence of any common law duty of care to you.

Privacy Statement

24. ALPG respects the privacy of the individuals on whom ALPG collects, uses and discloses personal information. The personal information that ALPG collects is used for the purpose of the sale and distribution of your Tickets, as reasonably required for the proper and efficient staging of the Event and to give effect to any of its rights under these Terms.
25. You may request access to personal information ALPG holds about you by sending an email to gameon@alpg.com.au.

General

26. ALPG may choose not to enforce a term of these Terms in some cases in its absolute discretion without affecting its right to enforce that term in other cases, including by replacing Tickets (except forged tickets) if you can demonstrate proof of purchase and identity acceptable to ALPG.
27. These Terms are governed by the law applicable in Queensland and each party irrevocably and unconditionally submits to the exclusive jurisdiction of the courts of Queensland.

Amendments

28. ALPG reserves the right to update, modify or change these Terms from time to time. Any changes will be available on ALPG's website.
